

St. Teresa's School Mansarovar Jaipur is run by Prabhudasi Sisters Education Society, Ajmer which is a registered body authorized to run schools, hospitals, dispensaries, old age homes, creche etc in different parts of the country. St. Teresa's School is an institution under the management of Prabhudasi Sisters Education Society Ajmer, which is a registered Society under Rajasthan Society Registration Act 1958. The school is co – educational and imparts education in English Medium (CBSE), Admissions are given to children of all communities treating their religious faith with due respect. The Academic year begins in April and ends in March.

#### **ADMISSION**

- 1. Admission is open to all irrespective of caste, creed or race.
- 2. A child must have completed a minimum of 2 years and 6 months to a maximum of 3 years and 6 months as on 1st April 2024 for admission to Nursery and correspondingly for higher classes.
- 3. Application for registration must be made on the prescribed form along with the following documents attached to it:
  - a. Two passport size photograph of child to be affixed in the space given in Registration form.
  - b.Self attested photocopy of Birth Certificate of the child issued from Municipal Corp. (Original to be brought at the time of depositing Registration Form)
  - c. Self attested photocopy of marksheet/report card of child's previous class.
  - d. Self attested photocopy of certificate or marksheet of parents highest qualification.
  - e. Original Transfer Certificate from child's previous school.
  - f. Self attested photocopy of residence proof.
  - g. Self attested photocopy of Aadhar card of child and both the parents.
  - h. Self attested photocopy of marksheet/report card of sibling(s) studying in this school, if any.
- 4. A child who is seeking admission for the first time has to produce Birth Certificate from the Municipal Corporation in support of proof of Date of Birth.
- 5. An interaction/ screening for subjects English, Mathematics and Hindi will be conducted to test the subject knowledge of the students seeking admission to Class Second and above.
- 6. List of successful students will be published in the school notice board on scheduled date.
- 7. Admission Form along with the admission fee should be submitted to the school office on or before the date mentioned in the list of successful students failing which the selection stands cancelled.
- 8. In no case a student will be admitted to a class higher than that for which he/she is entitled to.
- 9. Registration of a child does not guarantee the admission in the class applied for.
- 10. Registration Form will not be accepted if the required documents are not attached along with the Form.
- 11. A child who has already attended any school will not be granted admission without a School Leaving Certificate/Transfer Certificate (TC).
- 12. Provisional admission will be revoked if the child does not produce final examination result and Transfer certificate from the previous school within the specified time.
- 13. Documents once deposited along with the Registration Form will not be returned.
- 14. Fees once paid will not be refunded under any circumstances.
- 15. Registration Form is not transferable.
- 16. Those students who join the school at any time of the current academic year will have to pay the complete fees of that academic year.
- 17. Documents required for admission are not returned.
- 18.NO DONATION IS TAKEN FOR ADMISSION BY THE INSTITUTION OR ITS REPRESENTATIVE IN ANY CASE.

#### WITHDRAWAL OF THE CHILD

- 1. A pupil failing to be promoted may have to discontinue his studies in the school.
- 2. School Leaving Certificate/Transfer Certificate (TC) will be issued only after all the school dues have been cleared.
- 3. Intimation of minimum one month is required before the withdrawal of the child from the school

### **SCHOOL FEE**

- 1. All fees are payable for the entire 12 months of the year. No deduction in fee will be made for broken periods of absence.
- 2. School Fee should be paid at the any branch of HDFC Bank in four installments in the month of April, July, October and January on or before 20th failing which a fine of Rs.20/- will be charged each day after that.
- 3. All dues should be cleared before a student appears for any Periodic Assessments. Fee and charges are subject to revision from time to time.
- 4. Fee once paid will not be refunded under any circumstances.
- 5. The School Leaving Certificate will be issued only after all school dues have been cleared.
